QUITCLAIM DEED

(CORPORATE GRANTOR)

For the consideration of **ZERO AND NO/100-----(\$0.00)-----DOLLARS** and other valuable consideration in hand paid by Iowa Department of Transportation, the **CITY OF ANKENY, IOWA**, a municipal corporation organized and existing under the laws of the State of Iowa, does hereby convey to the **STATE OF IOWA**, all its right, title, estate, claim and demand in the following described real estate in Polk County, Iowa:

THE RIGHTS, TITLE, CLAIM, INTEREST, IF ANY, GRANTED IS TO LAND DESCRIBED AS FOLLOWS:

A PARCEL OF LAND LOCATED IN THE SOUTHWEST FRACTIONAL 1/4 OF SECTION 19, TOWNSHIP 80 NORTH, RANGE 23 WEST OF THE 5TH P.M., NOW INCLUDED IN AND FORMING A PART OF THE CITY OF ANKENY, POLK COUNTY, IOWA AS SHOWN ON THE ACQUISITION PLAT EXHIBIT "A", ATTACHED HERETO AND BY REFERENCE MADE A PART HEREOF AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER LOT 1, CREEKVIEW PLACE, BEING AN OFFICIAL PLAT; THENCE SOUTH 88°33'42" EAST ALONG THE SOUTH LINE OF SAID LOT 1, A DISTANCE OF 39.61 FEET; THENCE SOUTH 0°52'34" EAST, 113.82 FEET; THENCE SOUTH 4°50'04" WEST, 35.49 FEET; THENCE SOUTH 31°42'50" WEST, 82.70 FEET TO THE EAST RIGHT-OF-WAY LINE OF INTERSTATE 35; THENCE NORTH 5°44'12" EAST ALONG SAID EAST RIGHT-OF-WAY LINE, 105.73 FEET TO A CORNER ON SAID EAST RIGHT-OF-WAY LINE; THENCE NORTH 2°42'04" WEST CONTINUING ALONG SAID EAST RIGHT-OF-WAY LINE, 115.46 FEET TO THE POINT OF BEGINNING AND CONTAINING 0.16 ACRES (6,873 S.F.).

COMMENCING AT THE SOUTH 1/4 CORNER OF SAID SECTION 19; THENCE NORTH 89°47'18" WEST ALONG THE SOUTH LINE OF SAID SOUTHWEST FRACTIONAL 1/4, A DISTANCE OF 1,470.19 FEET TO THE EAST RIGHT-OF-WAY LINE OF INTERSTATE 35; THENCE NORTH 0°51'59" WEST ALONG SAID EAST RIGHT-OF-WAY LINE, 33.01 FEET TO THE NORTH RIGHT-OF-WAY LINE OF NE 86TH AVENUE AND TO THE POINT OF BEGINNING; THENCE NORTH 0°51'59" WEST CONTINUING ALONG SAID EAST RIGHT-OF-WAY LINE, 23.79 FEET TO A CORNER ON SAID EAST RIGHT-OF-WAY LINE; THENCE NORTH 1°48'47" WEST CONTINUING ALONG SAID EAST RIGHT-OF-WAY LINE, 797.78 FEET TO A CORNER ON SAID EAST RIGHT-OF-WAY LINE; THENCE NORTH 5°44'12" EAST CONTINUING ALONG SAID EAST RIGHT-OF-WAY LINE, 150.02 FEET; THENCE SOUTH 0°52'34" EAST, 970.56 FEET TO SAID NORTH RIGHT-OF-WAY LINE; THENCE NORTH 89°47'18" WEST ALONG SAID NORTH RIGHT-OF-WAY LINE, 4.24 FEET TO THE POINT OF BEGINNING AND CONTAINING 0.23 ACRES (9,967 S.F.).

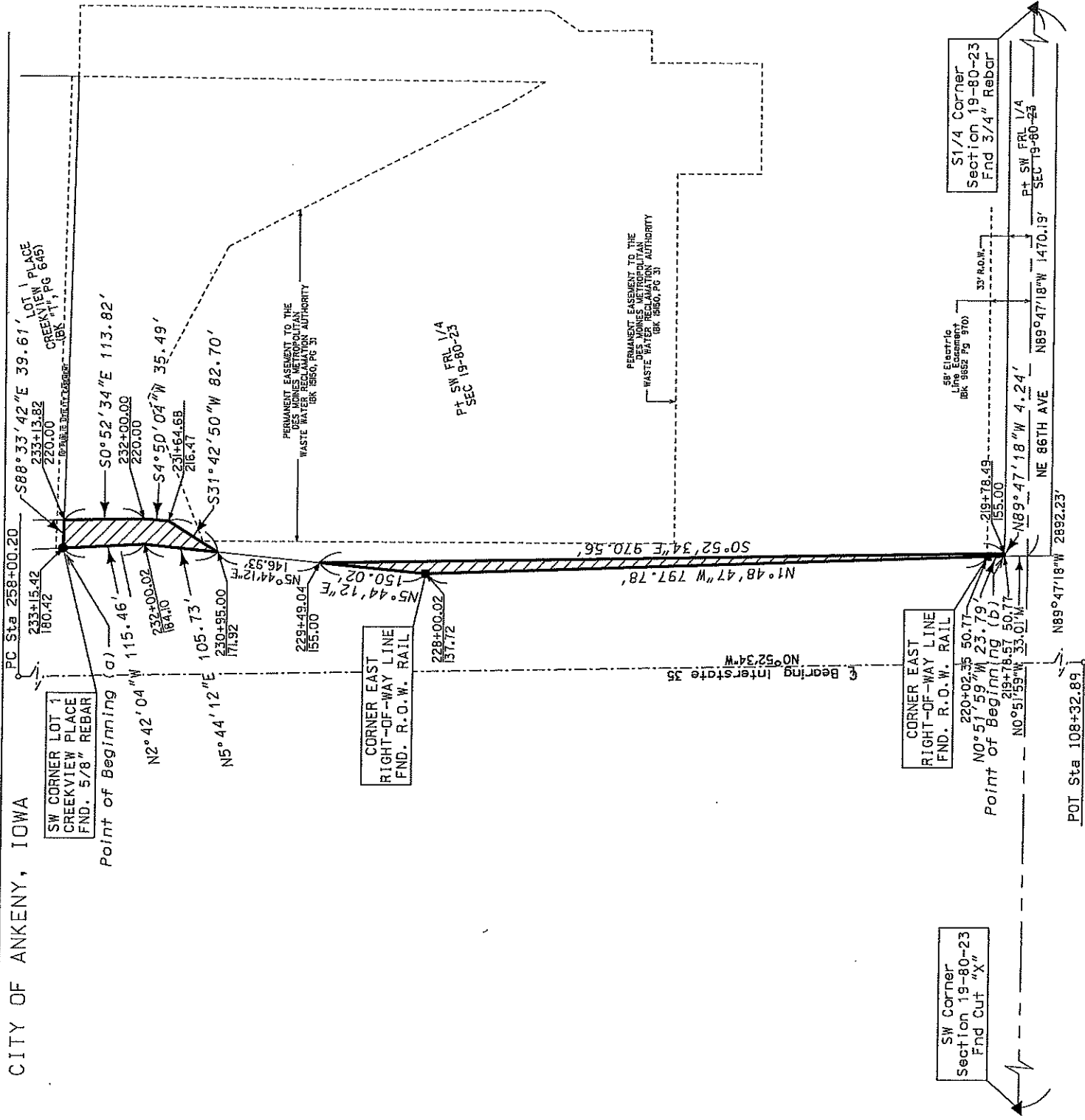

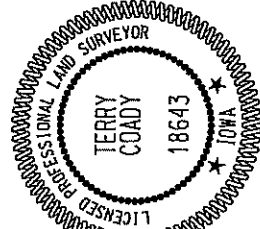

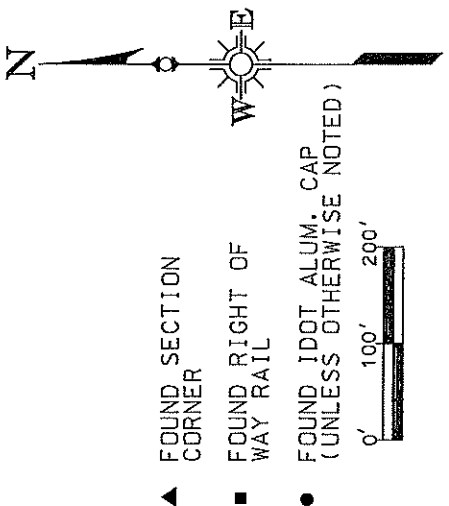
