RESOLUTION AUTHORIZING THE REDEMPTION OF OUTSTANDING SEWER REVENUE BONDS, SERIES 2010E, OF THE CITY OF ANKENY, STATE OF IOWA, DATED DECEMBER 15, 2010, AND DIRECTING NOTICE BE GIVEN

WHEREAS, the City did by resolution dated December 6, 2010, authorize the issuance of \$3,010,000 Sewer Revenue Bonds, Series 2010E, (the "Bonds") dated December 15, 2010; and

WHEREAS, the Bonds are redeemable in any order of their numbering on May 1, 2017 or any date thereafter upon giving notice in the manner provided in the resolution authorizing the issuance of the Bonds; and

WHEREAS, it is deemed necessary and advisable that \$2,245,000 be so redeemed on May 1, 2017 and notice of redemption be given according to the terms of the resolution authorizing issuance of the Bonds.
