Mayor Lorenz opened the public hearing. Notice of this hearing was published in the Des Moines Register on the 17th day of February, 2017.

No written objections were filed and no oral objections were offered from the audience.

Mark Mueller, Public Works Director, reported the 2017 PCC Street Patching Program project includes the full depth removal and replacement of PCC street pavement generally located on SE Delaware Avenue between SE Shurfine Drive and SE Magazine Road and on NW 18th Street between NW Ash Drive and NW School Street and in the City of Ankeny. Phase 1 consists of SE Delaware Avenue patches and Phase 2 consists of NW 18th Street patches.

The bid opening for the project was held on Tuesday, February 28, 2017 at which eight (8) bids were received with low bid submitted by JDA Construction Co., of Marshalltown, lowa, in the amount of \$\$200,000.00.

The engineer's estimate for the project was \$237,550.00. The bids ranged from approximately 16% below to 35% above the engineer's estimate. Jensen Builders has previously completed projects of similar nature for the City, including the 2016 PCC Street Patching Program project in 2016 and they have the technical experience to undertake this project. It is recommended that the project be awarded to JDA Construction Co., of Marshalltown, Iowa.

3. PH 2017-14: Proposed Hidden Creek Trunk Sewer Extension Project

Mayor Lorenz opened the public hearing. Notice of this hearing was published in the Des Moines Register on the 17th day of February, 2017.

No written objections were filed and no oral objections were offered from the audience.

Don Clark, Municipal Utilities Director, reported the Hidden Creek Trunk Sewer Extension project includes the removal and replacement of PCC street pavement, sanitary sewer main, erosion control and bank stabilization generally located south of the intersection of NW Weigel Drive and NW 18th Street in the City of Ankeny.

The bid opening for the project was held on Tuesday, February 28, 2017 at which eight (8) bids were received with low bid submitted by Graff Excavating, Inc., of Toledo Iowa, in the amount of \$\$226,340.00.

The engineer's estimate for the project was \$ 289,584.00. The bids ranged from approximately 22% below to 33% above the engineer's estimate. The City has requested and received references from Graff Excavating Inc., for similar projects and feedback given has been positive. It is recommended that the project be awarded to Graff Excavating Inc., of Toledo, Iowa.

Mayor Lorenz opened the public hearing. Notice of this hearing was published in the Des Moines Register on the 17th day of February, 2017.

No written objections were filed and no oral objections were offered from the audience.

Mark Mueller, Public Works Director, reported the 2017 Pedestrian Ramp Improvements project includes the removal and replacement of PCC pedestrian ramps within the Parkview Terrace neighborhood, generally located along and near NW School Street between NW 5th Street and NW 9th Street in the City of Ankeny.

The bid opening for the project was held on Tuesday, February 28, 2017 at which seven (7) bids were received with low bid submitted by Concrete Connection, LLC of Johnston, lowa, in the amount of \$76,660.00.

The engineer's estimate for the project was \$97,410.00. The bids ranged from approximately 21% below to 27% above the engineer's estimate. Concrete Connection, LLC has previously completed projects of similar nature for the City and they have the technical experience to undertake this project. It is recommended that the project be awarded to Concrete Connection, LLC of Johnston, Iowa.

Derek Lord, Economic Development Director, reported the proposed Amendment No. 7 to the 1989 Ankeny Economic Development Urban Renewal Plan, which was last amended in 2015, includes the following updates: Addition of proposed eligible urban renewal projects, update project costs and city financial data and expanded area objectives and types of renewal activities.

These updates are necessary for the reasons that the proposed projects in the recently approved CIP need to be reflected in the plan so tax increment financing can be an eligible source of financing for these projects; the proposed project costs need to be revised to reflect current cost estimates; and more clearly defines existing eligible uses, while including entrepreneurial support activities and improving recreation, tourism, cultural, and education opportunities as overall plan objectives.

Jennifer Sease, Administrative Services Director, reported there will be no increase in tax levies to be paid. Any increase in expenditures set out will be met from the increase of non-property tax revenues and cash balances not budgeted or considered in this current budget.

Significant changes requiring amendment of the current budget for fiscal year ending June 30, 2017 include amended revenues include increases in hotel/motel taxes, building permit fees, interest income, ambulance charges, plan review fees and civic trust contributions; amended expenditures include increases for the timing of capital projects and the payoff of sewer revenue bonds; and transfers in and transfers out increase due to additional general, road use tax, civic trust and capital projects reserve fund transfers to the capital projects fund to fund capital projects.
