TEMPORARY CONSTRUCTION EASEMENT

KNOW ALL BY THESE PRESENTS:

The Grantee has placed alternating driveways in its construction plans and agrees that one driveway shall remain open at all times and at no time shall a gravel driveway be installed on the property.
