C. PUBLIC HEARING(S):

1. **PH 2017-31:** Proposed Chautauqua Park Lake Recreational Trail Project.

Mayor Lorenz opened the public hearing. Notice of this hearing was published in the Des Moines Register on the 28th day of April, 2017.

No written objections were filed and no oral objections were offered from the audience.

Mark Mueller, Public Works Director, reported this project includes the construction of an 8-foot wide sidewalk through Chautauqua Park from SW White Birch Drive to SW Prairie Trail Parkway and along the park's frontage of SW White Birch Drive. This project will connect to a new pedestrian bridge that will be installed by a separate contractor over the drainage way that outlets to the lake.

The bid opening for the project was held on Tuesday, May 9, 2017 at which four (4) bids were received with low bid submitted by JAS Construction of Altoona, Iowa in the amount of \$190,192.95. The engineer's estimate for the project was \$255,103.00. The bids ranged from approximately 25% below to 2% below the engineer's estimate. Public

Works staff reviewed the bid results internally. JAS Construction has not previously completed projects for the City, but based on their references and relevant experience they have the technical experience to undertake this project. It is recommended that the project be awarded to JAS Construction of Altoona, Iowa.

Mayor Lorenz opened the public hearing. Notice of this hearing was published in the Des Moines Register on the 28th day of April, 2017.

No written objections were filed and no oral objections were offered from the audience.

Mark Mueller, Public Works Director, reported this project includes the construction of SW District Drive from just south of SW Magazine Road to just north of SW Prairie Trail Parkway and the construction of SW Merchant Street from 250 feet west of SW District Drive to just east of SW District Drive. 15,700 square feet of permeable parking pavers will be constructed as part of this project.

The bid opening for the project was held on Tuesday, May 9, 2017 at which eight (8) bids were received with low bid submitted by Quam Construction Company, Inc., in the amount of \$1,530,171.85. The engineer's estimate for the project was \$2,165,150.50. The bids ranged from approximately 30% below to 1% below the engineer's estimate. Public Works staff reviewed the bid results internally and with the engineering consultant. Public Works staff also requested and received references for Quam Construction Company, Inc., for similar projects and the feedback has been very positive. Based on their past project experience, they have the technical experience to undertake the project. It is recommended that the project be awarded to Quam Construction Company, Inc., of Willmar, Minnesota.

A. Fireworks Use and Sales

City Manager, David Jones, and Director of Planning & Building, Eric Jensen, provided a report on the proposed changes to city ordinances related to fireworks use and sales.

Discussion was held by council regarding the use of fireworks.
