Honorable Mayor and Members of the City Council:

We are pleased to submit the second partial payment application and second change order for work that occurred during the month of August in 2017.

The following is a summary of the work that occurred during this pay period:

- Seamus Excavating completed basin grading and topsoil respread on most areas of the project. Seamus also removed a 15-inch unknown cast iron pipe that had been identified in historical records within the southwest portion of Prairie Trail. Said removal of cast iron pipe is part of Change Order No. 2. Allender-Butzke Engineering tested the clay liner in both the north and south basins. Seamus construct armor mat to protect areas of the basins from storm water erosion.
- Soil-Tek installed 18" soil logs along the basins to prevent soil erosion from wave action along the water's edge.
- Gator Excavating constructed several different storm sewer pipe segments, and intake and manhole structures as an overall part of the storm sewer network. Gator also constructed rip rap to prevent storm water flow areas from wash-out.
- Allender-Butzke has been monitoring the basins for sand seams which would place the basins at risk for leaking. Allender-Butzke has recommended another 1,256 cubic yards of undercutting to remove and replace sandy material with suitable liner material (good clay). Said undercutting is part of Change Order No. 2.

Please review the enclosed partial payment application and change order which Nilles Associates recommends in full.
