ORDINANCE 1928

AN ORDINANCE AMENDING CHAPTER 69, PARKING REGULATIONS, OF THE MUNICIPAL CODE OF THE CITY OF ANKENY, IOWA, BY AMENDING SECTION 69.10, NO PARKING ON NORTH AND EAST SIDES OF STREETS, TO ALLOW FOR THE ADDITION OF "NO PARKING" ZONES ALONG:

- 1. THE NORTH SIDE OF NORTHWEST PARK MEADOWS DRIVE FROM NORTHWEST ASH DRIVE TO A POINT 200 FEET WEST OF NORTHWEST ASH DRIVE, AND
- 2. THE SOUTH SIDE OF NORTHWEST GEORGETOWN BOULEVARD FROM NORTHWEST ASH DRIVE TO A POINT 200 FEET EAST OF NORTHWEST ASH DRIVE, AND
- 3. THE WEST SIDE OF NORTHWEST BEECHWOOD STREET FROM NORTHWEST 18TH STREET TO A POINT 215 FEET NORTH OF NORTHWEST 18TH STREET.

BE IT ORDAINED, by the City Council of the City of Ankeny, Iowa:

<u>Section 1</u>. That Section 69.10, NO PARKING ON NORTH AND EAST SIDES OF STREETS, of the Municipal Code of the City of Ankeny, Iowa, be and it is hereby amended by adding subsections "2.AF." and "2.AG." and "2.AH." as follows:

- 2. Exceptions. Notwithstanding the provisions of this section, parking is authorized or prohibited along certain streets as hereinafter set forth:
 - AF. Northwest Park Meadows Drive. Parking is prohibited on the north side of Northwest Park Meadows Drive from Northwest Ash Drive to a point 200 feet west of the centerline of Northwest Ash Drive;
 - AG. Northwest Georgetown Boulevard. Parking is prohibited on the south side of Northwest Georgetown Boulevard from Northwest Ash Drive to a point 200 feet east of the centerline of Northwest Ash Drive;
 - AH. Northwest Beechwood Street. Parking is prohibited on the west side of Northwest Beechwood Street from Northwest 18th Street to a point 215 feet north of the centerline of Northwest 18th Street.
- <u>Section 2</u>. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

<u>Section 3</u>. This ordinance shall be in full force and effect after its passage, approval, and publication as provided by law.
