ORDINANCE 2019

AN ORDINANCE AMENDING CHAPTER 69, PARKING REGULATIONS, OF THE MUNICIPAL CODE OF THE CITY OF ANKENY, IOWA, BY AMENDING SECTION 69.10, NO PARKING ON NORTH AND EAST SIDES OF STREETS

BE IT ORDAINED, by the City Council of the City of Ankeny, Iowa:

- <u>Section 1</u>. That Section 69.10, NO PARKING ON NORTH AND EAST SIDES OF STREETS, of the Municipal Code of the City of Ankeny, Iowa, be and it is hereby amended by adding subsection "2.AJ" through "2.AQ" as follows:
- 2. Exceptions. Notwithstanding the provisions of this section, parking is authorized or prohibited along certain streets as hereinafter set forth:
 - AJ. Parking is prohibited on the south side of NW Georgetown Boulevard from North Ankeny Boulevard to a point 450 feet west of the centerline of North Ankeny Boulevard.
 - AK. Parking is prohibited on the south side of NE Georgetown Boulevard from North Ankeny Boulevard to a point 350 feet east of the centerline of North Ankeny Boulevard.
 - AL. Parking is prohibited on the south side of SW Prairie Trail Parkway from SW Vintage Parkway to a point 250 feet west of the centerline of SW State Street.
 - AM. Parking is prohibited on the south side of SW Prairie Trail Parkway from South Ankeny Boulevard to a point 250 feet west of the centerline of S Ankeny Boulevard.
 - AN. Parking is prohibited on the south side of NW 9th Street from NW Irvinedale Drive to a point 200 feet east of the centerline of NW Irvinedale Drive.
 - AO. Parking is prohibited on the south side of NW 5th Street from NW Irvinedale Drive to a point 160 feet east of the centerline of NW Irvinedale Drive.
 - AP. Parking is prohibited on the south side of NW 5th Street between NW Crestview Drive and NW Weigel Drive.
 - AQ. Parking is prohibited on the west side of SE Moyer Drive from SE Corporate Woods Drive to a point 500 feet north of the centerline of SE Corporate Woods Drive.
- <u>Section 2</u>. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.
