Whereupon, the Mayor declared the resolution duly adopted as follows:

RESOLUTION

RESOLUTION FIXING DATE FOR A MEETING ON THE PROPOSITION OF THE ISSUANCE OF NOT TO EXCEED \$6,600,000 WATER REVENUE BONDS, OF THE CITY OF ANKENY, STATE OF IOWA AND PROVIDING FOR PUBLICATION OF NOTICE THEREOF

WHEREAS, the City of Ankeny, State of Iowa, is in need of funds to carry out the purpose hereinafter described; and, it is deemed necessary and advisable that the City should issue Water Revenue Bonds, to the amount of not to exceed \$6,600,000, as authorized by Sections 384.82 and 384.83, of the City Code of Iowa, for the purpose of providing funds to pay costs thereof; and

WHEREAS, before the bonds may be issued, it is necessary to comply with the provisions of the Code, and to publish a notice of the proposal to issue such bonds and of the time and place of the meeting at which it is proposed to take action for the issuance of the bonds and to receive oral and/or written objections from any resident or property owner of the City to such action;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ANKENY, STATE OF IOWA:

Section 1. That this governing body meet in the Council Chambers, City Hall, 410 West First Street, Ankeny, Iowa, at <u>5:30</u> o'clock <u>P.M.</u>, on the 2nd day of April, 2018, for the purpose of taking action on the matter of the issuance of not to exceed \$6,600,000 Water Revenue Bonds of the City, the proceeds of which bonds will be used to provide funds to pay costs of constructing improvements and extensions to the Municipal Water Utility of the City.

Section 2. That the Clerk is hereby directed to cause at least one publication to be made of a notice of such meeting, in a legal newspaper, printed wholly in the English language, published at least once weekly, and having general circulation in the City, such publication to be not less than four clear days nor more than twenty days before the date of the public meeting on the issuance of the bonds.

PUBLIC NOTICE is hereby given that the City Council of the City of Ankeny, State of Iowa, will hold a public hearing on the 2nd day of April, 2018, at <u>5:30</u> o'clock <u>P</u>.M., in the Council Chambers, City Hall, 410 West First Street, Ankeny, Iowa, at which meeting the City Council proposes to take additional action for the issuance of not to exceed \$6,600,000 Water Revenue Bonds of the City. The bonds will not constitute general obligations or be payable in any manner by taxation, but will be payable from and secured by the net revenues of the Municipal Water Utility. The bonds are proposed to be issued for the purpose of paying costs of constructing improvements and extensions to the Municipal Water Utility of the City.
