1. PH 2018-25: Proposed 2018 PCC Reconstruction - NW Prairie Ridge Drive Project

Mayor Lorenz opened the public hearing. Notice of this hearing was published in the Des Moines Register on the 16th day of March, 2018.

No written objections were filed and no oral objections were offered from the audience.

Mark Mueller, Public Works Director, reported this project includes the full depth removal and replacement of PCC street pavement generally located in the northwest quadrant of the City of Ankeny, along NW Prairie Ridge Drive from 900 feet west of NW Ash Drive to NW Ash Drive.

The bid opening for this project was held on Tuesday, March 27, 2018 at which five (5) bids were received with low bid submitted by MNM Concrete Specialist in the amount of \$227,172.75

The Engineer's Estimate for the project was \$316,205.50. The bids ranged from approximately 28% below to 2% below the estimate. After review of the bid results it is recommended that the project be awarded to MNM Concrete Specialist of Des Moines, lowa.

2. PH 2018-26: Proposed SW Market Street Extension

Mayor Lorenz opened the public hearing. Notice of this hearing was published in the Des Moines Register on the 16th day of March, 2018.

No written objections were filed and no oral objections were offered from the audience.

Mark Mueller, Public Works Director, reported this project includes the construction of SW Market Street from the northerly end of the existing SW Market Street to the existing intersection with SW District Drive, construction of SW Park Square Drive from SW Market Street to the westerly end of existing SW Park Square Drive, construction of SW 16th Street from SW State Street to SW Market Street, and a right turn lane on SW State Street onto SW 16th Street.

The bid opening for the project was held on Tuesday, March 27, 2018 at which six (6) bids were received with low bid submitted by Sternquist Construction in the amount of \$813.616.76.

The engineer's estimate for the project was \$949,436.50. The bids ranged from approximately 14% below to 7% above the engineer's estimate. Public Works staff reviewed the bid results internally and with the consulting engineering firm who designed the project and it is recommended that the project be awarded to Sternquist Construction of Indianola, Iowa.

Eric Jensen, reported Kimberley Properties, Inc., on behalf of Wayne Abuhl, the property owner, has requested annexation to the City of Ankeny. The land is approximately 80 acres adjacent to the northeast quadrant of Ankeny, generally located north of NE 54th Street and west of NE 22nd Street (County). The proposed annexation area consists entirely of petitioned land and is contiguous with the corporate boundary of Ankeny. The annexation includes any and all Polk County road right-of-way to the centerline of the adjacent road. This annexation area is not identified on the future land use map of the current Comprehensive Plan. However, this area is identified in the draft 2040 Comprehensive Plan as Low Density Residential. Therefore, staff has told the applicant they will not be required to do a Land Use Plan Amendment if the property is developed as Low Density Residential. If the property is annexed, it will be zoned R-1, One-Family Residence District.

A review committee of City staff was assembled to review the proposals, interview selected consultants and made a recommendation to the Mayor and City Council that Confluence of Des Moines, Iowa, be hired to lead the Comprehensive Plan project for the City of Ankeny.

A Comprehensive Plan Advisory Team (CPAT) was established to serve as a steering committee to work with Confluence and City staff on this project. The CPAT worked with the consultant and City staff for approximately 18 months to prepare, review and modify The Ankeny Plan 2040. Staff finds the proposed draft plan as a plan that will guide the City as Ankeny continues to grow and develop.

Chris Shires, AICP / Principal, at Confluence, provided an overview of the development and proposed The Ankeny Plan 2040.
