Whereupon, the Mayor declared the following Resolution duly adopted:

### **RESOLUTION**

RESOLUTION ORDERING CONSTRUCTION OF THE NE  
DELAWARE AVENUE PEDESTRIAN BRIDGE OVER  
FOURMILE CREEK AND BRIDGE APPROACH GRADING,  
AND FIXING A DATE FOR HEARING THEREON AND  
TAKING OF BIDS THEREFOR

WHEREAS, it is deemed advisable and necessary to construct certain public improvements described in general as the NE Delaware Avenue Pedestrian Bridge Over Fourmile Creek and Bridge Approach Grading; and

WHEREAS, the City has caused to be prepared plans, specifications and form of contract, together with estimate of cost, which are now on file in the office of the City Clerk for public inspection, for the construction of the public improvements; and

WHEREAS, the plans, specifications and form of contract are deemed suitable for the making of the public improvements; and

WHEREAS, before the plans, specifications, form of contract and estimate of cost may be adopted, and contract for the construction of the public improvements is entered into, it is necessary, pursuant to Chapter 26 of the Code of Iowa, to hold a public hearing and to advertise for bids:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ANKENY, IOWA:

Section 1. That it is hereby determined that it is necessary and advisable to construct certain public improvements described in general as the NE Delaware Avenue Pedestrian Bridge Over Fourmile Creek and Bridge Approach Grading, in the manner set forth in the plans and

specifications and form of contract, above referred to, the cost thereof to be paid in accordance with the provisions as set out in the posted Notice to Bidders and published Notice of Public Hearing; the public improvements being more generally described as follows:

The NE Delaware Avenue Pedestrian Bridge Over Fourmile Creek and Bridge Approach Grading project includes the construction of a pedestrian bridge over Fourmile Creek and associated grading at the crossing on the west side of NE Delaware Avenue between NE 18<sup>th</sup> Street and NE 22<sup>nd</sup> Court in the City of Ankeny.

The construction improvements include earthwork, embankment construction, construction of a pre-engineered steel truss pedestrian bridge and related abutments, revetment stone slope protection, construction of sidewalk bridge approach pavement, surface restoration and miscellaneous associated work necessary to complete the project.

Section 2. That the amount of the bid security to accompany each bid shall be in an amount which shall conform to the provisions of the notice to bidders approved as a part of the specifications.

That the City Clerk is hereby directed to advertise for bids for the construction of the improvements. Pursuant to joint agreement with the Highway Division, Department of Transportation, the bids will be received and opened under the supervision of the Division at Office of Contracts, 800 Lincoln Way, in the City of Ames, Iowa, at 10:00 A.M. on May 15, 2018. The Contracts Engineer, Office of Contracts, Iowa Department of Transportation or his authorized representative is hereby named to attend at the opening of bids on behalf of the City. Thereupon the bids will be referred to the City Council for action upon the bids at a meeting to be held at the City Council, Council Chambers, City Hall, 410 West First Street, Ankeny, Iowa, on the 4th day of June, 2018, at 5:30 P.M. Notice to Bidders is to be posted once in a relevant contractor plan room service with statewide circulation and a relevant construction lead generating service with statewide circulation and on an internet site sponsored by either the City or a statewide association that represents the City. Posting shall be not less than thirteen clear days nor more than forty-five days prior to the date fixed for the receipt of bids.

That the City Council will hold a public hearing on the matter of the adoption of proposed plans, specifications and form of contract for the making of the improvements, which documents are now on file in the office of the City Clerk, the hearing to be held at the Council Chambers, City Hall, 410 West First Street, Ankeny, Iowa, on the 4th day of June, 2018, at 5:30 P.M., and that the City Clerk give notice of the hearing by publication once in a local legal newspaper, printed wholly in the English language, not less than four clear days nor more than twenty days prior to the date fixed therefor.
