He reported he would be attending the DART Annual Business Meeting and expressed thoughts as it relates to the election of Executive Committee and Officers that would take place at such meeting; and he requested Council consider the interview approach for selection of the Strategic Planning Consultant.

Council Member Bentz reported she would be attending the MAC meeting scheduled tomorrow, January 8, 2019.

Council Member Holm reported there would be a \$.74 increase in residential Curb-It! Fees effective July 1, 2019.

Council Member Walter-Ashby requested Council members take into account board member absenteeism as they consider a possible reduction in the number of |members on a Board or Commission.
