Scope of work will include:

1. Tree removal and disposal for Deer Creek Trunk Sewer Project. Includes grinding the trees and incorporating the wood chips into the topsoil 100 feet from the creek.
2. Installation of creek crossings for the Deer Creek Truck Sewer Project. This includes a 20' long 30" diameter pipe in each crossing and some rip rap on the upstream side.
3. Tree removal and disposal for Deer Creek Box Culvert Project. Includes grinding the trees and incorporating the wood chips into the topsoil 100 feet from the creek.

**Excludes:**

Erosion control measures and SWPPP Development and Implementation, survey, tree protection measures, tree trimming, marking of trees to be saved, traffic control, issues with endangered species, mowing, bonds, backfill, permits, railroad insurance policies and flaggers, additional mobilizations, removal of fence, trash, rubble, debris, and dirt with brush mixed in.
