RESOLUTION FIXING DATE FOR A MEETING ON THE PROPOSITION OF THE ISSUANCE OF NOT TO EXCEED \$6,075,000 WATER REVENUE BONDS, OF THE CITY OF ANKENY, STATE OF IOWA AND PROVIDING FOR PUBLICATION OF NOTICE THEREOF

WHEREAS, the City of Ankeny, State of Iowa, is in need of funds to carry out the purpose hereinafter described; and, it is deemed necessary and advisable that the City should issue Water Revenue Bonds, to the amount of not to exceed \$6,075,000, as authorized by Sections 384.82 and 384.83, of the City Code of Iowa, for the purpose of providing funds to pay costs thereof; and

WHEREAS, before the bonds may be issued, it is necessary to comply with the provisions of the Code, and to publish a notice of the proposal to issue such bonds and of the time and place of the meeting at which it is proposed to take action for the issuance of the bonds and to receive oral and/or written objections from any resident or property owner of the City to such action;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ANKENY, STATE OF IOWA:

Section 1. That this governing body meet in the Council Chambers, City Hall, 410 West First Street, Ankeny, Iowa, at <u>5:30</u> o'clock P.M., on the 18th day of February, 2019, for the purpose of taking action on the matter of the issuance of not to exceed \$6,075,000 Water
