C. PUBLIC HEARING(S):

1. **PH 2019-04**: Proposed NE 54th Street Bridge Replacement Over Branch of Fourmile Creek Project

Mayor Pro tem Holm opened the public hearing. Notice of this hearing was published in the Des Moines Register on the 18th day of December, 2018.

Mark Mueller, Public Works Director, reported the NE 54th Street Bridge Replacement Over Branch of Fourmile Creek project includes the removal and replacement of the existing roadway bridge, reconstruction of the existing roadway and 8-ft. & 5-ft. sidewalk connections on NE 54th Street between NE Briarwood Drive and NE Hillcrest Drive in the City of Ankeny.

The majority of this project's construction is being funded through the federal-aid Swap City Highway Bridge Program (HBP) and Surface Transportation Block Grant (STBG) Program, so the project was bid through the Iowa Department of Transportation (DOT).

The bid opening for the project was held by the Iowa DOT on Wednesday, January 16, 2019, at which four (4) bids were received. The engineer's estimate for the project was \$1,284,406.60. The bids ranged from approximately 0.5% below to 21% above the estimate. The City reviewed the bid results both internally and with the project's engineering consultant. Herberger Construction Co., Inc., has previously completed projects of similar nature in this area and they have the technical experience to undertake this project. It is recommended that the project be awarded to Herberger Construction Co., Inc., of Indianola, Iowa.

 PH 2019-05: Proposed High Trestle Trail Extension - SW Ordnance Road to SE Magazine Road Project

Mayor Pro tem Holm opened the public hearing. Notice of this hearing was published in the Des Moines Register on the 18th day of December, 2018.

The High Trestle Trail Extension - SW Ordnance Road to SE Magazine Road project consists of the construction of a PCC trail along old railroad grade and under US Highway 69 by means of a cast-in-place RCB pedestrian tunnel with formliner. The Engineer's Estimate for the project was \$1,566,946.00. The bids ranged from approximately 31% above to 109% above the estimate.

The bid opening for this project was held on Tuesday, January 29, 2019 at which Four (4) bids were received and the engineer's estimate for the project was \$1,566,946.00. The bids ranged from approximately 31% above to 109% above the estimate.

The City's Public Works staff, the design engineering consultant and the lowa DOT have reviewed the bid results and Public Works staff contacted several contractors who were on the plan holders list following the bid.

The bids received were substantially higher than expected and the low bid amount significantly exceeds the amount of funding allocated for this project in the 2019 Capital Improvements Program.

The High Trestle Trail Extension project is considered a high priority project for the City of Ankeny and the Des Moines MPO. However, given the bid results and feedback received from contractors following the bid, it is recommended that the bids be rejected at this time. The Iowa DOT and the design engineering consultant have concurred with this recommendation.
