PERMANENT ROADWAY EASEMENT

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, Jaxwil Enterprises, Inc. (Deed Holder) and WW Futures II, LLC (Contract Buyer), of the City of Ankeny, County of Polk, State of Iowa, hereinafter referred to as "Grantor", in consideration of the sum of one dollar (\$1.00), and other valuable consideration, in hand paid by the City of Ankeny, Iowa, receipt of which is hereby acknowledged, do hereby sell, grant and convey unto the State of Iowa, hereinafter referred to as "Grantee" or "State", a permanent easement under, through, and across the following described real estate:

That the above-described easement is granted unto the State of Iowa, for the purpose of constructing, reconstructing, repairing, replacing, enlarging, inspecting and maintaining the following public improvements:

ROADWAY EASEMENT

- 1. <u>Erection and Placement of Structures, Obstructions, Plantings or Materials Prohibited.</u>
 Grantor and its grantees, assigns and transferees shall not erect any fence or other structure under, over, on, through, across or within the Easement Area without obtaining the prior written consent of the State, nor shall Grantor cause or permit any obstruction, planting or material to be placed under, over, on, through, across or within the Easement Area without obtaining the prior written consent of the State.
- 2. <u>Change of Grade Prohibited.</u> Grantor and its grantees, assigns and transferees shall not change the grade, elevation or contour of any part of the Easement Area without obtaining the prior written consent of the State. The State shall have the right to restore any changes in grade, elevation or contour without prior written consent of the Grantor, its grantees, assigns or transferees.
- 3. <u>Right of Access</u>. The State shall have the right of access to the Easement Area and have all rights of ingress and egress reasonably necessary for the use and enjoyment of the Easement Area from property adjacent thereto as herein described, including but not limited to, the right to remove any unauthorized fences, structures, obstruction, planting or material placed or erected under, over, on,

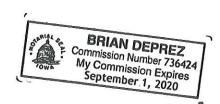
through, across or within the Easement Area.

- 4. <u>Property to be Restored</u>. The State shall restore the Easement Area after exercising its rights hereunder, provided, however, that the State's duty of restoration shall be limited to grading and replacing grass, sod or any other ground cover (but not including any structures, trees or shrubs). The State shall not be responsible for any construction, reconstruction, replacement, repair or maintenance of any improvements located within the Easement Area.
- 5. <u>Liability</u>. Except as may be caused by the negligent acts or omissions of the State, its employees, agents or its representatives, the State shall not be liable for injury or property damage occurring in or to the Easement Area, the property abutting said Easement Area, nor for property damage or any improvements or obstructions thereon resulting from the State's exercise of this Easement.
- 6. <u>Easement Benefit</u>. This Easement shall be for the benefit of the State, its successors and assigns, and its permittees and licensees.
- 7. <u>Easement Runs with Land</u>. This Easement shall be deemed perpetual and to run with the land and shall be binding on Grantor and on Grantor's heirs, successors and assigns.
- 8. <u>Consent and Subordination of Mortgage Holder(s)</u>. By signing this Agreement, the undersigned lender, its successors and assigns consents to the terms of this easement agreement and hereby subordinates its interest in the Easement Area to the interest of the State and its successors and assigns.
- 9. <u>Approval by City Council</u>. This Easement shall not be binding until it has received the final approval and acceptance by the City of Ankeny, Iowa, Council by Resolution which approval and acceptance shall be noted on this Easement by the Deputy City Clerk.

That the Grantor does hereby covenant with the said Grantee, and successor-in-interest, that said Grantor holds said real estate by title and fee simple; that it has good and lawful authority to sell and convey the same; that said premises are free and clear of all liens and encumbrances whatsoever, except as may be herein stated; that said Grantor covenants to warrant and defend the said premises against the lawful claims of all persons whomsoever, except as may be herein stated.
