- 1. Persons engaging in soliciting by operating out of a vehicle (street vendors) shall provide a certified copy of his or her current driving record.
- 2. If a new applicant resided outside of lowa anytime during the five years before applying, the person must also obtain, at their own expense, a copy of his or her current criminal history background report and certified copy of driving record from each state of residence during the prior five years.
- 3. Any person whose license has been suspended or revoked, or has expired for more than 30 days, will be required to obtain a State DCI certified stamped copy of current criminal history background report and certified driving record in the same manner as a new applicant.
- 4. A list of all convictions (convicted of, pled guilty to or stipulated to the facts of a criminal offense) for criminal offenses, other than traffic offenses, during the ten years immediately preceding the date of application.
