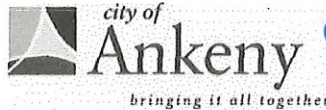

ADDITIONAL REQUIREMENTS PER THE ANKENY CITY CODE OF ORDINANCES:

(Please read and supply records if necessary.)

1. Persons engaging in soliciting by operating out of a vehicle (street vendors) shall provide a certified copy of his or her current driving record.
2. If a new applicant resided outside of Iowa anytime during the five years before applying, the person must also obtain, at their own expense, a copy of his or her current criminal history background report and certified copy of driving record from each state of residence during the prior five years.
3. Any person whose license has been suspended or revoked, or has expired for more than 30 days, will be required to obtain a State DCI certified stamped copy of current criminal history background report and certified driving record in the same manner as a new applicant.
4. A list of all convictions (convicted of, pled guilty to or stipulated to the facts of a criminal offense) for criminal offenses, other than traffic offenses, during the ten years immediately preceding the date of application.
5. A list of all convictions for traffic violations for which the applicant's license was suspended, revoked or barred during the five year immediately preceding the date of application.
6. Mobile Food Vendors (other than prepackaged) are required to submit Operational Permit Application to the Ankeny Fire Department, see attachment.
7. Transient Merchant Applications require written permission from property owner to operate on property.

Please note: the process to obtain these reports may take anywhere from one to six weeks.

Pursuant to Municipal Code Chapter 132.11 - Hours of solicitation in the City of Ankeny are from 9 a.m. to 7 p.m., Monday through Saturday. No soliciting on Sundays or National Holidays.
