AN ORDINANCE AMENDING THE ZONING REGULATIONS, CHAPTER 192, OF THE MUNICIPAL CODE OF THE CITY OF ANKENY, IOWA, BY REZONING CERTAIN REAL ESTATE OWNED BY ROSE MARIE REINHART

WHEREAS, the Plan and Zoning Commission of the City of Ankeny, Iowa, held a public hearing and on the 19th day of March, 2019 recommended to the City Council that the Zoning Regulations, Chapter 192, of the Municipal Code of the City of Ankeny, Iowa, for the following described properties owned by Rose Marie Reinhart from the current R-1, One-Family Residence District, to R-3, Multiple-Family Residence District with restrictions.

WHEREAS, on the ___day of _____, 2019, after due notice and hearing provided by law, the Council now deems it reasonable and appropriate to rezone the properties described below from the current R-1, One-Family Residence District, to R-3, Multiple-Family Residence District with restrictions.
