Mayor Lorenz called the meeting to order at 5:30 PM. All Council Members were in attendance. City Manager, David Jones and City Attorney, Amy Beattie were present. Mayor Lorenz led the Pledge of Allegiance.

PUBLIC FORUM:

Ann Tiernan, 1018 NW Reinhart Drive, spoke on behalf of the Chamber of Commerce. Ann shared upcoming Chamber events.

APPROVAL OF AGENDA:

PUBLIC HEARING(S):

1. PH 2019-58 Mayor Lorenz state that this is the time and the place for a public hearing on a proposed amendment to the Zoning Regulations, Chapter 192 of the Municipal Code of the City of Ankeny, Iowa, by rezoning certain real estate owned by D.R. Horton - Iowa LLC, from the current R-1, One-Family Residence District, to R-2, One-Family and Two-Family Residence District. Notice of this hearing was published in the Des Moines Register on the 7th day of September, 2019.

Eric Jensen, Director of Planning and Building, provide a report on this proposed rezoning. D.R. Horton - Iowa LLC is requesting to rezone property from R-1, One-Family Residence District, to R-2, One-Family and Two-Family Residence District. The subject property is approximately 10 acres, located east of NW Abilene Road and approximately a third of a mile north of NW 36th Street. The properties to the north, south and east of the proposed rezoning area are zoned R-1, One-Family Residence District. The property to the west is zoned R-2, One-Family and Two-Family Residence District.
