# RESOLUTION APPROVING AN EMERGENCY WATERSHED PROTECTION EASEMENT BETWEEN THE CITY OF ANKENY, IOWA AND THE UNITED STATES OF AMERICA

WHEREAS, the City of Ankeny acquired property that is subject to an Emergency Watershed Protection Program Floodplain Warranty Easement Deed ("Easement") recorded on April 6, 2012 in Book 14225 at Page 1 in the Polk County Recorder's Office;

**WHEREAS**, the City requested that the Easement be removed from a part of the property in order to facilitate a City roadway project;

**WHEREAS**, property was removed from the Easement as requested by the City in exchange for an equal or greater area being granted in a subsequent easement;

**WHEREAS**, the City of Ankeny has provided to the United States of America documentation required for approval of the new easement area by the Regional Office of General Counsel;

**WHEREAS**, the United States of America requests approval by the City Council of the City of Ankeny in the form of a Resolution before forwarding all documentation to the General Counsel; and

**WHEREAS**, the City Council of the City of Ankeny believes it is in the best interest of the City to grant the easement which will supersede the Easement recorded on April 6, 2012 in Book 14225 at Page 1 and to approve an Emergency Watershed Protection Program Floodplain Warranty Easement Deed to the United States of America.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Ankeny, Iowa, that an Emergency Watershed Protection Program Floodplain Warranty Easement is hereby granted to the United States of America for the following described property:

A PART OF THE NORTHEAST 1/4 OF THE NORTHWEST FRACTIONAL 1/4 OF SECTION 19, TOWNSHIP 80 NORTH, RANGE 23 WEST OF THE 5TH P.M., NOW INCLUDED IN AND FORMING A PART OF THE CITY OF ANKENY, POLK COUNTY, IOWA AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTH 1/4 CORNER OF SAID SECTION 19; THENCE SOUTH 0°31'42" EAST ALONG THE EAST LINE OF SAID NORTHWEST FRACTIONAL 1/4, A DISTANCE OF 703.57 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING SOUTH 00°31'42" EAST ALONG SAID EAST LINE OF NORTHWEST FRACTIONAL 1/4
