 - A. The Engineer will prepare up to two (2) permanent easement plats, legal descriptions, and exhibits. If the Owner determines additional acquisition plats or legal descriptions are necessary, then the Engineer shall prepare these at a prorated rate. Work includes research and associated field work.

Add the following Section XI:

XI. Bidding Phase Services

A. Bid Documents

- 1) Furnish plans, specifications, and contract documents of the Project to the Owner and prospective bidders via upload to QuestCDN.
- 2) Issue addenda as appropriate to clarify, correct, or change bidding documents.

B. Advertising

- 1) Answer questions from potential contractors, subcontractors, and suppliers, and coordinate with the Owner during the phase of services.

C. Bid Opening

- 1) The project will be let by the Owner and the Engineer will:
 - a. Attend bid opening
 - b. Confirm as bid prices
 - c. Prepare tabulation of construction bids
 - d. Prepare Contract and PPM Bond forms
 - e. Recommend award of contract to the Owner
