#### **ORDINANCE 2012**

## AN ORDINANCE AMENDING THE ZONING REGULATIONS, CHAPTER 192, OF THE MUNICIPAL CODE OF THE CITY OF ANKENY, IOWA, BY REZONING CERTAIN REAL ESTATE OWNED BY D.R.A. PROPERTIES, LC

**WHEREAS,** the Plan and Zoning Commission of the City of Ankeny, Iowa, held a public hearing and on the 3<sup>rd</sup> day of March, 2020, recommended to the City Council that the Zoning Regulations, Chapter 192, of the Municipal Code of the City of Ankeny, Iowa, for the following described property, owned by D.R.A. Properties, LC, to be rezoned from the current R-1, One-Family Residence District, to R-3, Multiple-Family Residence District with restrictions; and

**WHEREAS**, on the 4<sup>th</sup> day of May, 2020, after due notice and hearing provided by law, the Council now deems it reasonable and appropriate to rezone the following described property:

# NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANKENY, IOWA:

- 1. That Chapter 192 of the Municipal Code of the City of Ankeny, Iowa, is hereby amended by rezoning the above-described property owned by D.R.A. Properties, LC, from the current R-1, One-Family Residence District, to R-3, Multiple-Family Residence District with restrictions;
- 2. That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed; and
- 3. That this ordinance shall be in full force and effect after its passage, approval and publication as provided by law.
