This is the eleventh progress report for the above referenced project and covers work from February 14, 2020, through April 16, 2020. Work invoiced through this period includes construction services including construction administration and observation.

The project was let on August 13, 2019 and awarded to Sternquist Construction. Work has resumed after the winter shutdown period. Subgrade preparation has commenced.

The project engineering services costs included on this invoice of \$6,321.21, are 80% eligible /20% ineligible for RISE reimbursement at a rate of 50%. A total of \$2,528.48 would be funded through the RISE Grant. Reimbursement for sums from the developer will be provided in accordance with the terms of the development agreement.
