# AN ORDINANCE AMENDING THE ZONING REGULATIONS, CHAPTER 192, OF THE MUNICIPAL CODE OF THE CITY OF ANKENY, IOWA, BY REZONING CERTAIN REAL ESTATE OWNED BY DTK PROPERTIES, LLC

WHEREAS, the Plan and Zoning Commission of the City of Ankeny, Iowa, held a public hearing and on the 5<sup>th</sup> day of May, 2020, recommended to the City Council that the Zoning Regulations, Chapter 192, of the Municipal Code of the City of Ankeny, Iowa, for the following described property, owned by DTK Properties, LLC, to be rezoned from the current R-1, One-Family Residence District, to M-1, Light Industrial District; and

**WHEREAS,** on the 6<sup>th</sup> day of July, 2020, after due notice and hearing provided by law, the Council now deems it reasonable and appropriate to rezone the following described property:

THAT PART OF THE EAST 478.5 FEET OF THE NORTH ½ OF SAID NORTHEAST ¼ OF SECTION 7, LYING SOUTH OF CORPORATE WOODS DRIVE AND WEST OF SE FOURMILE DRIVE.

ALL CONTAINING 12.8 ACRES MORE OR LESS.

- 1. That Chapter 192 of the Municipal Code of the City of Ankeny, Iowa, is hereby amended by rezoning the above-described property owned by DTK Properties, LLC, from the current R-1, One-Family Residence District, to M-1, Light Industrial District; and
- 2. That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed; and
- 3. That this ordinance shall be in full force and effect after its passage, approval and publication as provided by law.
