## MINUTES OF THE ANKENY CITY COUNCIL

Monday, June 1, 2020 5:30 PM
Ankeny Kirkendall Library - City Council Chambers

Mayor Lorenz called the meeting to order at 5:30 PM. Due to Covid-19 Pandemic council members Perry, Walter-Ashby, Whiting joined the meeting via conference call. Council Members Bobbi Bentz and Mark Holm were present. City Manager David Jones, and City Attorney Amy Beattie were also present.

Todd Wehr, Shive-Hattery Project Manager, presented a 3D version of the proposed Ankeny Senior Community Center to be located west of Fire Station No. 1 off of NW Ash in Ankeny. This project is a joint City of Ankeny and Polk County venture. Mayor and council members had a few questions, but overall liked the concept of the building.

# **PUBLIC FORUM**

- 1. Mary Jo Blumer, 1723 SW Franklin Dr, Ankeny, lowa presented pictures regarding a fence that is located in a drainage area at the rear of her home by her neighbor to the back of her. She believes this fence is causing drainage back up and flooding her backyard. City Manager agreed to have staff look at a drainage intake located near her home and submit a report for council on what the city controls in this situation.
- 2. Dan Manning, Attorney with Lillis O'Malley Olson Manning Pose Templeman LLP, 317 6<sup>th</sup> Ave, Des Moines, representing Deer Creek Estates, LLC, voiced concerns regarding the approval of a policy for improvements on street crossings of existing waterways within the City of Ankeny. He asked council to not approve the policy that will be considered later in the meeting. This is a policy that was deferred on April 20 and has since been revised.

## APPROVAL OF AGENDA

1. Council member Holm moved, second by Walter-Ashby, to approve and accept the June 1, 2020 agenda, without amendment. Ayes: 5.

## **PUBLIC HEARINGS**

1. PH 2020-32. Mayor Lorenz announced this is the time and place for a public hearing on the matter of the proposed Ordinance 2014 amending the zoning regulations, Chapter 192, of the Municipal Code of the City of Ankeny, Iowa, by rezoning certain real estate owned by DTK Properties, LLC from its current R-1, One-Family Residence District to M-1, Light Industrial District. Notice of this hearing was published in the Des Moines Register on the 22nd day of May 2020, and notices were mailed to affected property owners as required by law.

Eric Carstens, Planning and Building, filling in for Director Eric Jensen, reported that the applicant, DTK Properties, LLC, is requesting to rezone property from R-1, One-Family Residence District to M-1, Light Industrial District. The area subject to the proposed rezoning—comprised of two parcels—is approximately 12.8 acres (+/-), located southwest of the intersection at SE Four Mile Drive and SE Corporate Woods Drive, and is zoned R-1, One-Family Residence District. The proposed rezoning to M-1, Light Industrial District,

is aligned with The Ankeny Plan 2040 Future Land Use Map, which defines this parcel as light industrial and open space/floodplain.

Mayor Lorenz then asked for any public comment regarding the proposed Ordinance 2014 amending the zoning regulations. Hearing no comments, Council Member Whiting moved to close public hearing 2020-32, Walter-Ashby seconded. Ayes: 5.

2. PH 2020-33. Mayor Lorenz announced that this is the time and place for a public hearing for the proposed Ordinance 2015 vacating a portion of an entrance easement located on Lot 1 and Street Lot 'A', Corporate Woods Business Park Plat 5. Notice of this hearing was published in the Des Moines Register on the 22nd day of May, 2020.

Eric Carstens, Planning and Building, filling in for Director Eric Jensen, reported the City has received a request to vacate a portion of a 40-foot entrance easement located on Lot 1 and Street Lot 'A', Corporate Woods Business Park Plat 5. The purpose of the vacation request is to allow construction of the future extension of SE Convenience Boulevard, south of SE Corporate Woods Drive.

Mayor Lorenz then asked for any public comment regarding the proposed Ordinance 2015 vacating a portion of an entrance easement located on Lot 1 and Street Lot 'A', Corporate Woods Business Park Plat 5. Hearing no comments, Council Member Holm moved to close public hearing 2020-33, Bentz seconded. Ayes: 5.

3. PH 2020-34. Mayor Lorenz announced that this is the time and place for a public hearing on the matter to consider a proposed conveyance of improvements, property and permanent easements to the Des Moines Metropolitan Wastewater Reclamation Authority. Notice of this hearing was published in the Des Moines Register on the 22nd day of May, 2020.

Paul Moritz, Assistant City Manager, provided a report that as part of the terms and conditions for the WRA to own and maintain the Rock Creek Sewer, each affected city including Ankeny was directed to convey easements for the sewer to the WRA. These easements are located across the street rights-of-way or are located on other city-owned property. All necessary sewer easements across private property were acquired prior to construction.

Mayor Lorenz then asked for any public comment regarding the conveyance of the sewer easements to the WRA. Hearing no comments, Council Member Walter-Ashby moved to close public hearing 2020-34, Whiting seconded. Ayes: 5.

4. PH 2020-35. Mayor Lorenz announced that this is the time and place for a public hearing on the matter of the adoption of plans, specifications, form of contract and estimate of cost for construction of certain public improvements described in general as construction of the Heritage Park Parking Lot Resurfacing project. Notice of this hearing was published in the Des Moines Register on the 15th day of May 2020.

Nick Lenox, Park and Recreation Director, reported that the Heritage Park Parking Lot Resurfacing project includes the rehabilitation and widening of the existing parking lot at Heritage Park along Frisk Drive in Ankeny, Iowa. The project also consists of earthwork, PCC curb and gutter, driveway replacement, painted pavement markings, pipe culvert

installation, erosion control, surface restoration, and other associated work necessary to complete the project, generally located within the Heritage Park parking lot.

Mayor Lorenz then asked for any public comment regarding the Heritage Park Parking Lot Resurfacing project. Hearing no comments, Council Member Bentz moved to close public hearing 2020-35, Perry seconded. Ayes: 5.

5. PH 2020-36. Mayor Lorenz announced that this is the time and place for a public hearing on the matter of a proposed development agreement between the City of Ankeny and Ryan Companies US, Inc. related to business expansion. The Notice of Hearing on this proposal was published in the Des Moines Register on the 22nd day of May 2020.

Derek Lord, Director of Economic Development, reported that Ryan Company is proposing to construct an approximately \$20 million, 350,000 sf warehouse on approx. 35 acres on the west side of SE Delaware Ave., immediately south of the Toro Distribution Center. Ryan Companies is currently working with a prospective tenant who would lease the entire facility.

Mayor Lorenz then asked for any public comment regarding the Heritage Park Parking Lot Resurfacing project. David Wilson, Ryan Companies, thanked council for their consideration. Hearing no other comments, Council Member Holm moved to close public hearing 2020-36, Whiting seconded. Ayes: 5.

# **ADMINISTRATIVE BUSINESS**

- David Jones informed City Council that he planned on moving forward with a small number of new positions that were planned for in the budget.
- Mayor Lorenz thanked council and staff for hanging in there during the unprecedented Covid 19 challenges
- Bentz explained that she felt she didn't have enough information to consider opening the
  pools at this time. She stated she felt she needed more policy and state directions on
  opening. She noted that this is a decision that management makes and council does not
  typically make this type of decision.

- Holm noted that he would like to wait until closer to June 17 to make a decision on the pool. He also noted he was concerned about the loss of money, but understood that the safety of residents should come first.
- Perry inquired about the status of the Human Rights Commission. Mayor informed him
  that they had held off because they wanted to commence face-to-face interviews and
  because of Covid had put that off. Mayor Lorenz indicated that they may make
  arrangements to start interviews practicing social distancing.
- Walter-Ashby noted she agreed with all of the comments concerning the pool and mentioned that a work session closer to June 17 might be warranted. She also thanked Chief Potts, all the Rescue personnel, and staff for their hard work.
- Whiting also thanked Chief Potts and PD for their help in being deployed during the riots in Des Moines. She stated "in regards to the pool discussion while certainly disappointed in a lack of a second, she was not surprised. The CDC categorized visiting a public pool as less hazardous than getting a haircut so she does think the longer we pontificate and create red tape around it, the less likely it is that we will actually open it because the financial burden does get heavier. Several private clubs, pools, and obviously many home owners are about to open their pools in the city so by not opening the pool we as a city are perpetuating a situation of the haves and have-nots in terms of swimming lessons and general recreation access."

Ayes: Holm, Bentz, Perry, Walter-Ashby, Whiting. Council adjourned the executive meeting at 7:09 PM.
