MINUTES OF THE ANKENY CITY COUNCIL

Mayor Mark Holm called the meeting to order at 5:30 p.m. Council Members Bobbi Bentz, Jeff Perry, Joe Ruddy, Todd Shafer and Kelly Stearns were in attendance. City Manager David Jones and City Attorney Amy Beattie were also present. Mayor Holm led in the Pledge of Allegiance.

APPROVAL OF AGENDA

1. Council Member Bentz moved, Shafer seconded, to approve and accept the February 20, 2023 agenda as presented. Ayes: 5.

PUBLIC HEARING

PH 2023-12. Mayor Holm announced this is the time and place for a public hearing on the
matter of the proposed Ordinance 2132 amending the zoning regulations, Chapter 192, of the
Municipal Code of the City of Ankeny, Iowa, by rezoning certain real estate owned by NGR,
Inc. Notice of this hearing was published in the Des Moines Register on the 10th day of
February, 2023 and notices were mailed to affected property owners as required by law.

Eric Jensen, Director of Community Development, reported that the applicant, Hubbell Realty Company, on behalf of NGR, Inc., is requesting to rezone property from R-1, One-Family Residence District to M-1, Light Industrial District. The area subject to the proposed rezoning consists of one parcel and totals approximately 31.17 acres (+/-). The subject area is generally located three-quarters of a mile north of SE Corporate Woods Dr and immediately east of SE Four Mile Dr. Surrounding properties to the southwest and west are zoned M-1, Light Industrial District. Properties to the east and north are not within Ankeny's Corporate Limits. The proposed rezoning aligns with the *Ankeny Plan 2040 Future Land Use Map*, which identifies the subject parcel as being suitable for Airport Business Park uses and Open Space. Per the *Ankeny Plan 2040*, the M-1, Light Industrial District is listed as being a compatible zoning district within the Airport Business Park future land use classification.

Mayor Holm then asked for any public comment regarding the proposed rezoning. William Pearce, 6868 NE Berwick Dr, Ankeny voiced concerns and invited the Mayor and Council to visit the woods. Jim Krohse, 6734 NE Berwick Dr, Ankeny voiced concerns about the rezoning. Clint Sloss of Hubbell Development Service and Dustin Creech of Engineering Resource Group answered questions about the project. Council Member Shafer moved, Bentz seconded, to close public hearing 2023-12. Ayes: 5.

2. PH 2023-13. Mayor Holm announced this is the time and place for a public hearing on the matter of the proposed review of an application for State Revolving Fund (SRF) Loan and to make available to the public the contents of an environmental information document and the City's project plan. The proposed project involves the construction of the NW Water Tower. Notice of this hearing was published in the Des Moines Register on the 6th day of January, 2023.

Don Clark, Municipal Utilities Director, reported that the project will utilize the State Revolving Fund to provide a lower rate of interest. The purpose of this project is to provide additional

water storage and more reliable water pressure and flow to the northwest quadrant of Ankeny. This tower will be sourced with water from the NW Booster Station. This project is still being designed, but the intention is to have it out for bid in the Spring of 2023, with construction to follow in the summer of 2023 that will likely continue into 2024.

Mayor Holm then asked for any public comment regarding the proposed project. Hearing no comments, Council Member Bentz moved, Stearns seconded, to close public hearing 2023-13. Ayes: 5.

3. PH 2023-14. Mayor Holm announced this is the time and place for a public hearing on the matter of the adoption of plans, specifications, form of contract and estimate of cost for construction of certain public improvements described in general as construction of the 2023 PCC Street Patching Program. Notice of this hearing was published in the Des Moines Register on the 3rd day of February, 2023.

Mark Mueller, Public Works Director, reported the project includes the full depth removal and replacement of PCC street pavement at four separate locations, generally located on: Site 1 – East First St between Ankeny Blvd and Delaware Ave; Site 2 – NW State St between West First St and NW 9th St; Site 3 – SW Glenbrooke Blvd and SW 29th St intersection; and Site 4 – NE 16th St and NE Innsbruck Court intersection. Other associated improvements include sidewalk and pedestrian ramp removal and replacement, minor adjustments to sanitary and storm sewer structures, partial rebuild of an existing intake, temporary traffic control, temporary lane separator system, maintenance of postal service and solid waste collection, temporary surface restoration, mobilization, and miscellaneous associated work necessary to complete the project.

Mayor Holm then asked for any public comment regarding the proposed project. Hearing no comments, Council Member Stearns moved, Ruddy seconded, to close public hearing 2023-14. Ayes: 5.

4. PH 2023-15. Mayor Holm announced this is the time and place for a public hearing on the matter of the adoption of plans, specifications, form of contract and estimate of cost for construction of certain public improvements described in general as construction of the 2023 PCC Reconstruction Program – SE Creekview Dr. Notice of this hearing was published in the Des Moines Register on the 3rd day of February, 2023.

Mark Mueller, Public Works Director, reported the project includes PCC pavement reconstruction of the northbound lanes of SE Creekview Dr from just north of SE Oralabor Rd to just north of SE Tones Dr. Other associated improvements include Class 10 excavation, subgrade preparation, modified subbase placement, subdrain removal and replacement, minor adjustments to existing storm sewer structures, pedestrian ramp improvements, temporary surface restoration, temporary traffic control, mobilization, and miscellaneous associated work necessary to complete the project.

Mayor Holm then asked for any public comment regarding the proposed project. Hearing no comments, Council Member Stearns moved, Shafer seconded, to close public hearing 2023-15. Ayes: 5.
