Whereupon, the Mayor declared the following Resolution duly adopted:

### **RESOLUTION**

RESOLUTION RATIFYING, CONFIRMING, AND APPROVING THE CHANGE IN DATES FOR SUBMISSION OF BIDS AND FOR PUBLIC HEARING ON PLANS, SPECIFICATIONS, FORM OF CONTRACT AND ESTIMATE OF COSTS FOR THE DELAWARE GROUND STORAGE RESERVOIR REHABILITATION

WHEREAS, on April 17, 2023, the Council adopted a Resolution ordering construction of the Delaware Ground Storage Reservoir Rehabilitation; and

WHEREAS, pursuant to said Resolution, the City Clerk was directed to post the notice to bidders not less than thirteen clear days nor more than forty-five days prior to May 9, 2023, the date fixed for receiving bids; and

WHEREAS, pursuant to said Resolution, the City Clerk was directed to publish notice of public hearing not less than four clear days nor more than twenty days prior to May 15, 2023, the date fixed as the date for a public hearing on the plans, specifications, form of contract and estimate of costs for the project; and

WHEREAS, the Notice to Bidders and Notice of Public Hearing was not timely posted on a relevant contractor plan room service with statewide circulation, a relevant construction lead generating service with statewide circulation or on an internet site sponsored by the city or a statewide association that represents the city and it is therefore necessary to reschedule the bid deadline and public hearing in this matter.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ANKENY, IOWA:

Section 1. That the actions of the Project Engineer in changing the time and date for the receipt of bids to before 10:30 A.M. on May 30, 2023 is hereby ratified, confirmed, and approved.

Section 2. That the actions of the Project Engineer in changing the time and date for the public hearing on the plans, specifications, form of contract and estimate of costs to June 5, 2023 is hereby ratified, confirmed, and approved.

Section 3. That the actions of the City Clerk in posting a revised Notice to Bidders and Notice of Public Hearing once in a relevant contractor plan room service with statewide circulation and a relevant construction lead generating service with statewide circulation and on an internet site sponsored by the City not less than thirteen clear days nor more than forty-five days prior to May 30, 2023 is hereby ratified, confirmed, and approved.

Section 4. That the City Council hereby delegates to the City Clerk or her designee the duty of receiving, opening and tabulating bids for construction of the Project. Bids shall be received and opened as provided in the public notice and the results of the bids shall be considered at the meeting of this Council on June 5, 2023, at 5:30 P.M.

Section 5. That the actions of the City Clerk in publishing a revised Notice to Bidders and Notice of Public Hearing in a legal newspaper, printed wholly in the English language, published at least once weekly and having general circulation in this City, not less than four clear days nor more than twenty days prior to the date hereinafter fixed as the date for a public hearing on the plans, specifications, form of contract and estimate of costs for the project, the hearing to be held at 5:30 o'clock P.M. on June 5, 2023, is hereby ratified, affirmed, and confirmed.

Section 6. That the form of the amended Notice to Bidders and Notice of Public Hearing for the Delaware Ground Storage Reservoir Rehabilitation is hereby ratified, confirmed, and approved.
