PUBLIC HEARING

1. PH 2024-01. Mayor Holm announced this is the time and place for a public hearing for the purpose of amending the current budget for fiscal year ending June 30, 2024 by changing estimates of revenue and expenditure appropriations. There will be no increase in tax levies to be paid. Any increase in expenditures set out will be met from the increase of non-property tax revenues and cash balances not budgeted or considered in this current budget. Notice of this hearing was published in the Des Moines Register on the 21st day of December 2023.

Jennifer Sease, Administrative Services Director, reported that public works expenditures are being amended to include the estimated cost of the special census. It was originally anticipated that these costs would occur in FY 2025, but the U.S. Census Bureau has requested payment in advance for the work to be scheduled in CY 2024.
